1. The Pauwadungma Rural Municipality invites electronic bids from eligible bidders for the procurement of Mini Tiller-02 under National competitive bidding – Single Stage Single Envelope procedures.
2. Under the Single Stage, Single Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Pauwadungma Rural Municipality, Chyangre, Bhojpur, pauwadungmamun@gmail.com or may visit PPMO eGP system www.bolpatra.gov.np/egp.
4. A complete set of bidding documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of **NRs. 3000** for bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-bid meeting shall be held at Pauwadungma Rural Municipality, Bhojpur at **13:00 hrs on 2083-02-06**
6. Sealed or electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **2083-02-14 on 12:00**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2083-02-14** at the office of **Pauwadungma Rural Municipality, Bhojpur**. Bids must be valid for a period of **120 days** from the date of bid



opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2,00,000 , which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
